PLEASE GIVE ANY FURTHER DETAILS. *AK Inverness Cadillac in Merritt Island, Fla. replaced the accumulator, but did not correct the problem. They said the whole ABS system had to be replaced for \$4800. That \$4800 plus the \$600 in repairs the last 1 1/2 years, plus the fear of losing your brakes as I 95 made me let the car sit until someone says it is ok. Cadillac said they may pay 1/2 of the \$4800 bill.
