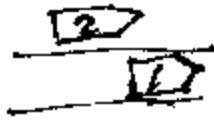

I HAVE had Dodge vans and Ford vans and they both have the same problem. Auto parts stores sell small mirrors to correct this unsafe condition. I sent the instruction card for placing this small mirror to your Dept. Manufacturers should correct this unsafe blind spot on the side view mirror. Many accidents may be caused by this condition. Testing should show the problem.
