The man that sold my car made the car lie about its condition right up to the signing of the Bill of Sale. He took advantage of a 18yr girl. The right air Bag was not there. Connections for Driver side air Bag - have been cut off. Driver side air Bag re-check completion operations found air Bag monitor is bad. Passenger side air bag has been removed & cover reinstalled. Used air Bag was on driver side.
