FIRESTONE TIRE - AFFINITY HP P195/65 R15 89H M/S IS VERY SOFT, WEARS EXCESSIVELY EARLY AND APPEARS TO LEAK AIR ALTHOUGH THERE IS NO EVIDENCE OF TIRE PUNCTURES OR HOLES.

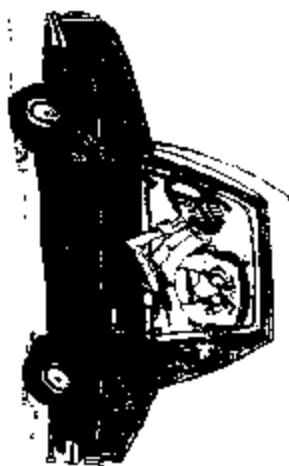
