WHILE DRIVING DOWN ROAD APPLIED BRAKES AND TRANSMISSION JUMPED HARD INTO A LOWER GEAR AND THEN BRAKES WOULD GRAB. DRIVING ON HIGHWAY, TRAVELLING 35MPH WITH SNOW ON THE ROAD AND COMING OFF A RAMP, TAPPED THE BRAKES, AND ALL WHEELS LOCKED UP, AND VEHICLE WENT OUT OF CONTROL. HIT A POLE. CONTACTED DEALER. DEALER INFORMED CONSUMER THAT THE TRANSMISSION WAS CAUSING THE PROBLEM. ALSO, THIS WAS THE SECOND TIME VEHICLE WENT OUT OF CONTROL. WAS ALSO TOLD THAT TRANSMISSION WAS BEING REDESIGNED.
