* The identification number consists of 7 to 10 letters and numerals following the letters DOT. It is usually located near the rim flange on the side opposite the whitewall or on either side of a blackwall tire.

NARRATIVE DESCRIPTION (CONTINUED)

Both sideview, outside mirrors started folding in when the truck was 6 years old (1998). In October 1998 I bought a new Ford replacement drivers side mirror. This mirror started to fold in around February 2000. This mirror lasted approximately 15,000 miles/16 months. Warm weather contributes to the failure. Windy weather also causes the mirrors to fold in. These mirrors are a serious safety concern. I have seen other Ford Rangers that are around the same model year with duct tape wrapped around the mirror pedestal as a form of support. I will be glad to mail you both mirrors if you need them. One of them is the original equipment and the other one is the replacement bought in 10/98.
