This has happened two times. The mileage experienced for each of the two Fuel Gage Sending Units was about 30,000. Chrysler claims they are not aware of such problems with their vehicles. I do not believe I am the only person who could be on their third Fuel Gage Sending Unit @ 66,000 miles. If I got this many bad ones, so have others.
