VEHICLE WAS EXPERIENCING THE EXACT SAME PROBLEMS AS INDICATED IN MANUFACTURER'S RECALL 9424. MANUFACTURER ADVISED CONSUMER THAT THIS VEHICLE WAS NOT INCLUDED IN THE RECALL DUE TO VIN. MANUFACTURER'S RECALL STATED THAT LOWER CONTROL ARM ATTACHING BRACKETS COULD CRACK DUE TO FATIGUE, AND SEPARATE FROM THE ENGINE CRADLE. CONSUMER'S VEHICLE LOWER CONTROL ARM ATTACHING BRACKETS HAVE ALREADY STARTED TO CRACK. *AK
