CONSUMER WAS DRIVING AT 50 MPH WHEN VEHICLE STARTED TO ACCELERATE ON ITS OWN , HITTING SPEEDS OF 80 MPH. CONSUMER APPLIED BRAKES, BUT DID NOT OVERRIDE THE ACCELARATION.
