WAS DRIVING 35MPH & APPLIED BRAKES WHICH WERE GOING UP & DOWN. THEY FAILED TO STOP VEHICLE. WOULD SHIMMY OR SHAKE WHEN MAKING TURNS. WAS GOING DOWN HILL, AND WENT INTO A SKID. CROSSED DOUBLE LINE TO THE LEFT WHILE TRYING TO GO RIGHT. STEERING WAS UNCONTROLLABLE. ANOTHER VEHICLE "T" BONED THE VEHICLE ON PASSENGER SIDE. AIR BAGS DEPLOYED. VEHICLE WAS ONLY 34 DAYS OLD.
