THE WHEEL NUTS TENDS TO STRIP THE BOLT THREAD WHEN BEING PUT ON OR TAKEN OFF WITH AN IMPACT WENCH. THE NUTS CAN NOT BE PUT BACK ON NOR CAN IT BE TAKEN OFF WITHOUT CUTTING IT SOMETIMES DUE TO THE STRIPPED THREAD. SOMETIMES THE WHEEL NUTS/BOLTS WOULD FALL OFF BECAUSE OF A LACK OF THREAD. HAVE BOTH BOLTS & NUTS.
