EA95-026, CONSUMER WAS DRIVING IN GENERAL TRAFFIC ABOUT 20 MPH, GOING FROM STOP TO STOP. CONSUMER APPLIED BRAKES AS NORMAL WITH ENOUGH SPACE, BUT VEHICLE WAS NOT STOPPING FAST ENOUGH. CONSUMER APPLIED BRAKES AGAIN HARDER, BUT BRAKES DID NOT RESPOND. VEHICLE WAS STILL SLOWING DOWN AT SAME RATE OF SPEED, CAUSING A REAREND CRASH. PRIOR TO INCIDENT, CONSUMER NOTICED THAT IT TOOK LONGER TO STOP, ABOUT 5 FEET FURTHER IN A NORMAL STOPPING CONDITION. *AK
