CONVERSION VAN WITH AFTERMARKET SEATS THAT RECLINE & SWERVE, NOT MOUNTED ON MANUFACTURER'S BASE. PEDESTAL WAS BUILT TO BOLT SEAT. MAIN HOLDING 4 1/4 X20 BOLTS WITH 3/8 NUT. THIS FAILED TO HOLD SEAT PROPERLY. SEATS WOULD MOVE AROUND. AK - 2 of 4 "CAPTAINS SEATS," BACK SUPPORT FRAMES BROKE CAUSING BACK to lay down; MOUNTING BASE OF MILD STEEL WILL BEND EASILY. ALL "CONVERSION VANS" WITH CAPTAINS SEATS SHOULD BE LOOKED INTO. CAN NOT BE IMPACT SAFE.
