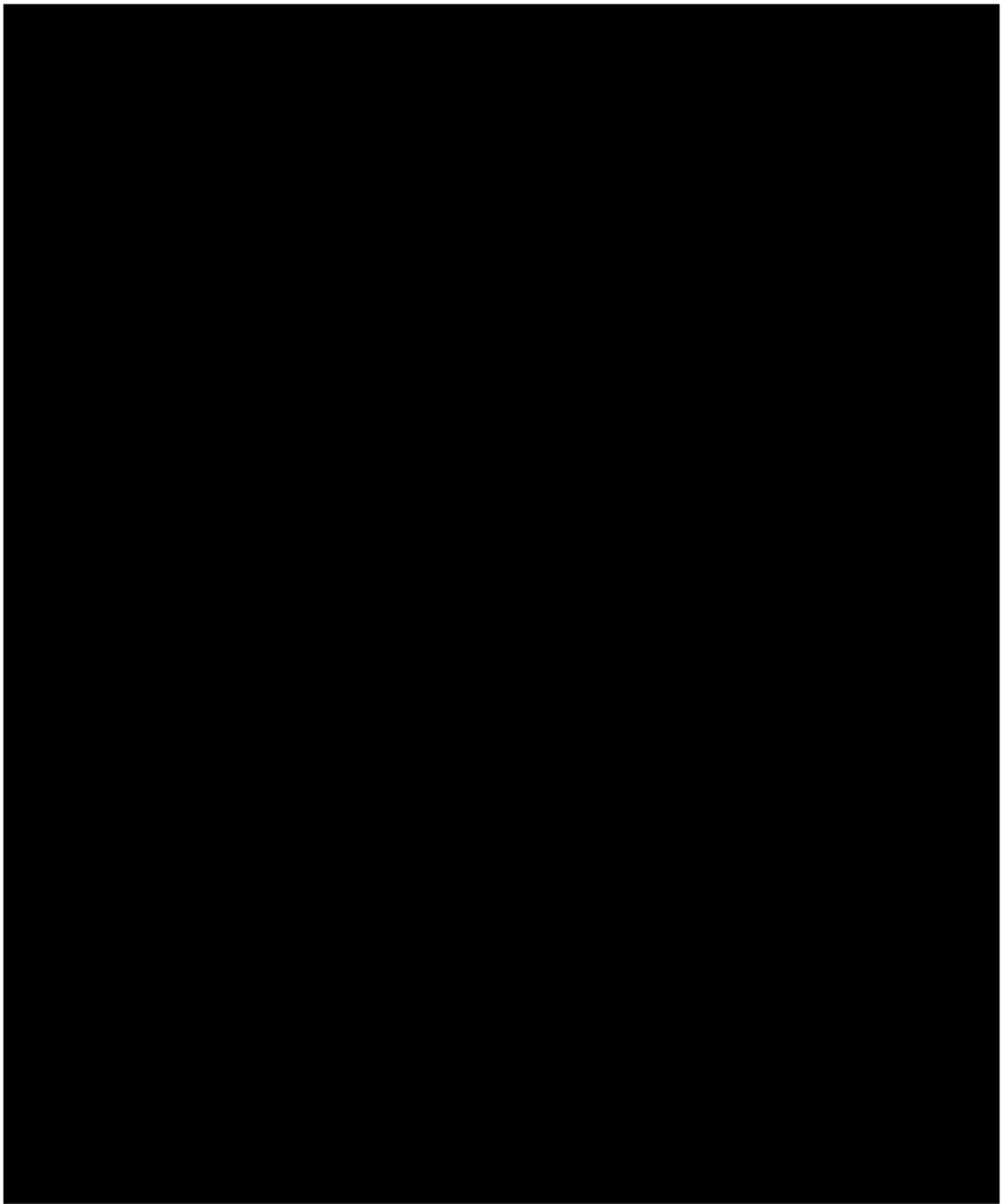
4/3 Chrysler called my husband at work & said they won't replace part for free - just warranty

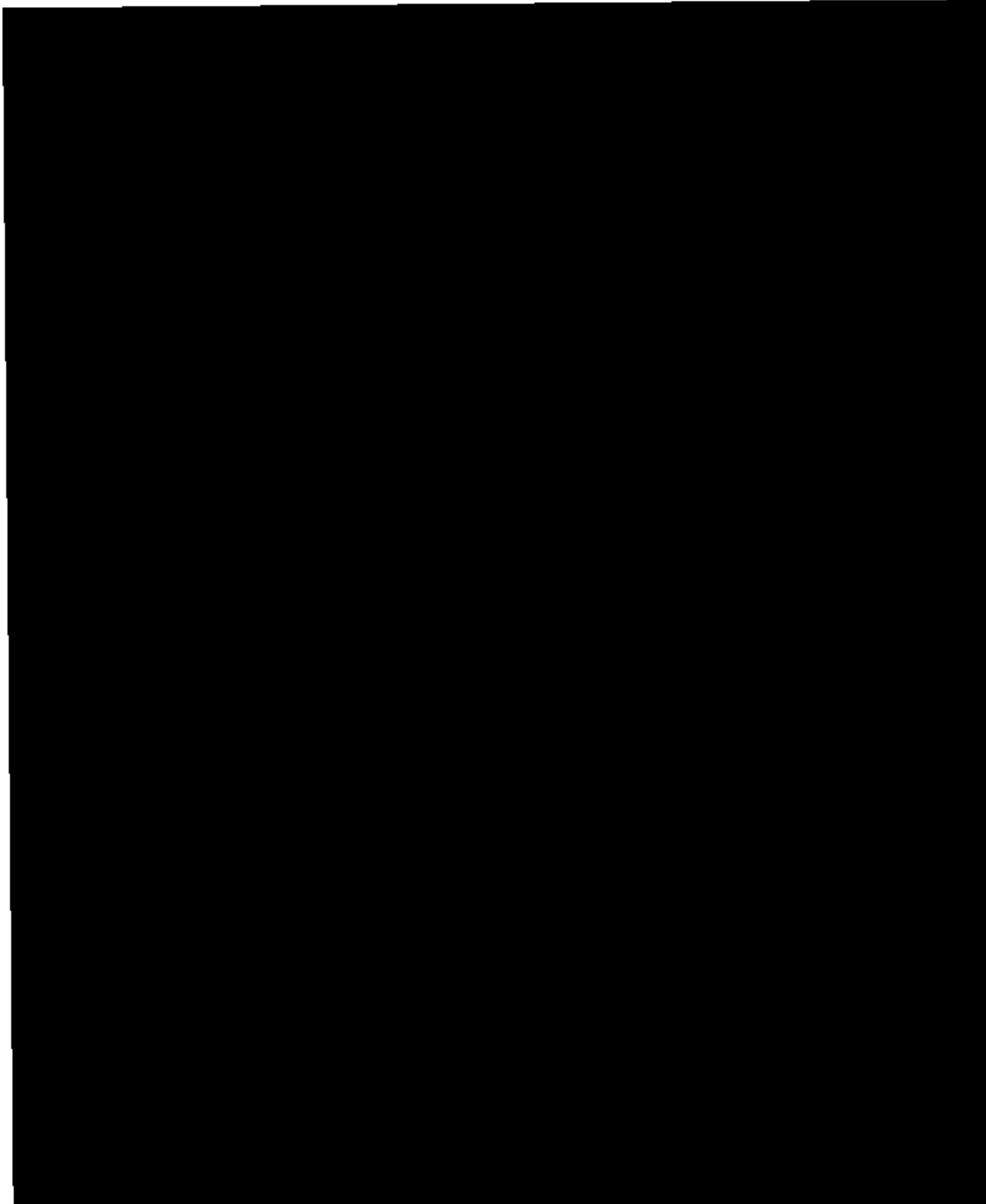

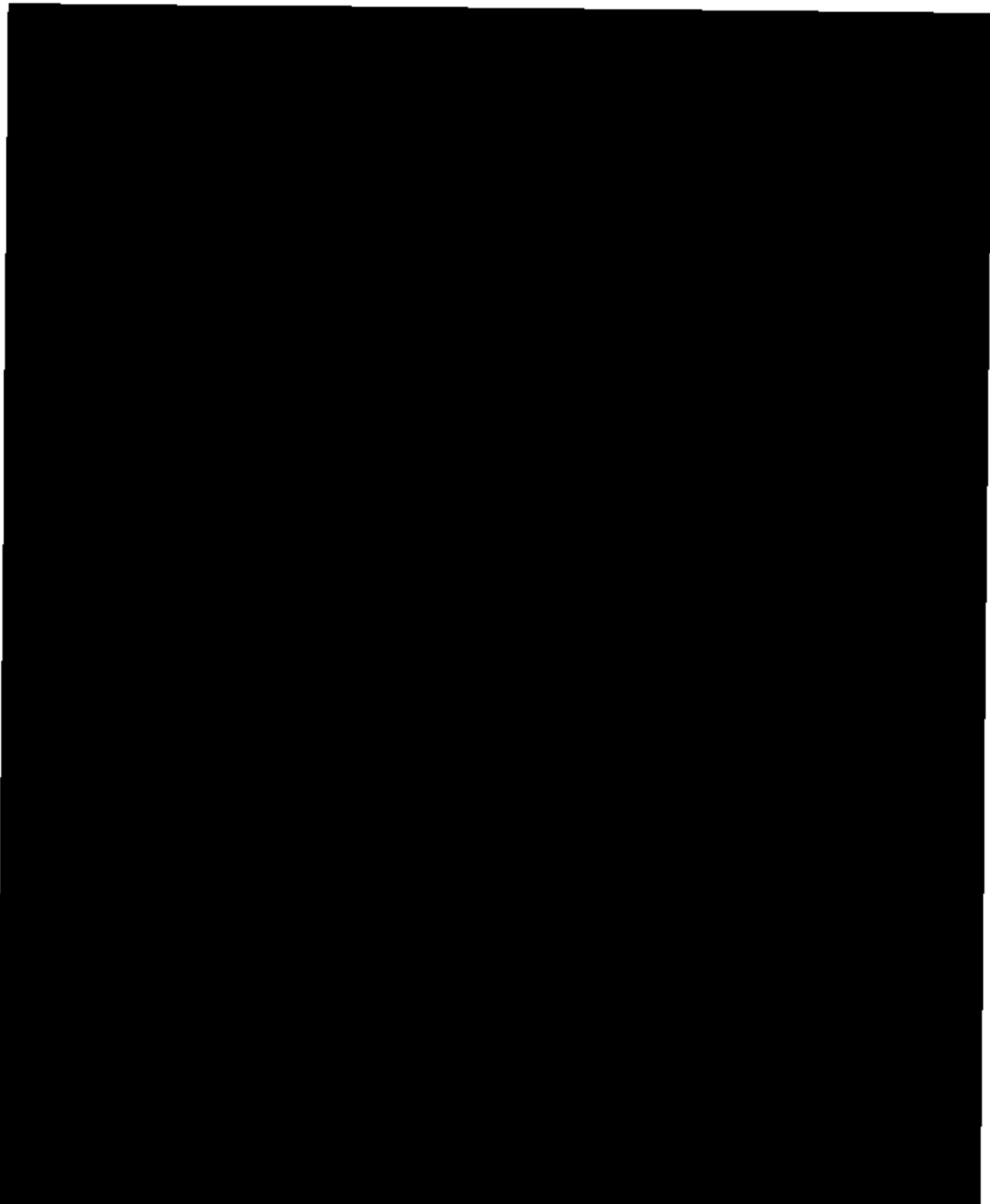
