CALLED DEALER (PREMIER PONTIAC, BUICK, GMC; KINGWOOD, TX; PHONE# 281/359-3600), AND INFORMED OF PROBLEM AND RECALL NOTICE. DEALER INFORMED CONSUMER THAT THEY WILL REPAIRS ALL DAMAGES DUE TO RECALL. LATER ON, INFORMED THAT OTHER DAMAGES WHICH WERE NOT RELATED TO THE RECALL WOULD BE REPAIRED AT CONSUMER'S EXPENSE.
