My prior vehicle, a Volvo 850, nor any vehicles before this period have NOT had this clogging/vibration problem. It appears to be something that adversely affects ALL alloy-wheel equipped vehicles! Recommendations have run from brush all wheels after driving through mud or snow, to spraying teflon on the inside rims. Unfortunately, by the time I know the problem exists, I'm doing 75mph on I-25. I then have the wheels balanced at the earliest opportunity, assuming I'm still alive!
