The first failure, both rear (excluding middle-belt) belts broke - belt hanging & would not retract. The 2nd & 3rd times, same thing. Belts would apparently get 'twisted' inside the frame & would not pull out or retract. This happened with 2 different child seats and an adult. An engineer was sent from Mazda on 6/7/01 →
