CONSUMER WAS DRIVING HOME FROM DEALER AFTER BEING SERVICED, AND WHEN APPLYING BRAKES, PEDAL WENT STRAIGHT TO FLOOR. CONSUMER DROVE BACK TO DEALER, AND STATED THAT IT WAS NORMAL FOR VEHICLE TO DO THAT. CONSUMER DIDN'T HAVE ANY PROBLEMS WITH BRAKE PEDAL WHEN FIRST PURCHASED.
