WHILE DRIVING 65 MPH HEARD A GRINDING SOUND FROM LEFT FRONT WHEEL. THEN, 3 LOUD CLICKS. SHE PULLED OVER TO CHECK WHEEL, AND WAS ABLE TO MOVE LEFT FRONT TIRE BACK AND FORTH WITH BOTH HANDS ABOUT 2 INCHES. SHE THEN DROVE AT A SLOW SPEED TO NEAREST DEALER. DEALER REPLACED DUST BOOTS ON BOTH FRONT WHEELS/ REPLACED BEARINGS, AND BOTH ENDS OF AXLE. ON THE WAY HOME AFTER THIS REPAIR, VEHICLE MADE SAME NOISE AGAIN. VEHICLE AT DEALER AT THIS TIME. DEALER STATED THIS WAS A KNOWN PROBLEM ON 2000 SPORTAGE.\*AK
