CONSUMER RECEIVED NHTSA RECALL NOTICE 00V421002000/MANUFACTURER'S RECALL 967. VEHICLE WAS STARTING TO MAKE A RATTLING NOISE, AND CONSUMER DECIDED TO HAVE IT CHECKED OUT. DEALER FOUND NO PROBLEM, AND STATED THAT BALL JOINTS WERE OKAY, AND DIDN'T NEED TO BE REPAIRED. RATTLING NOISE GOT WORSE, AND CONSUMER WENT TO A MECHANIC WHO WOULD NOT LET VEHICLE LEAVE THE LOT BECAUSE BALL JOINTS WERE DEFECTIVE, AND VEHICLE COULD EASILY LOSE STEERING. CONSUMER HAS BEEN WAITING FOR CONTACT SINCE JULY FROM MANUFACTURER.
