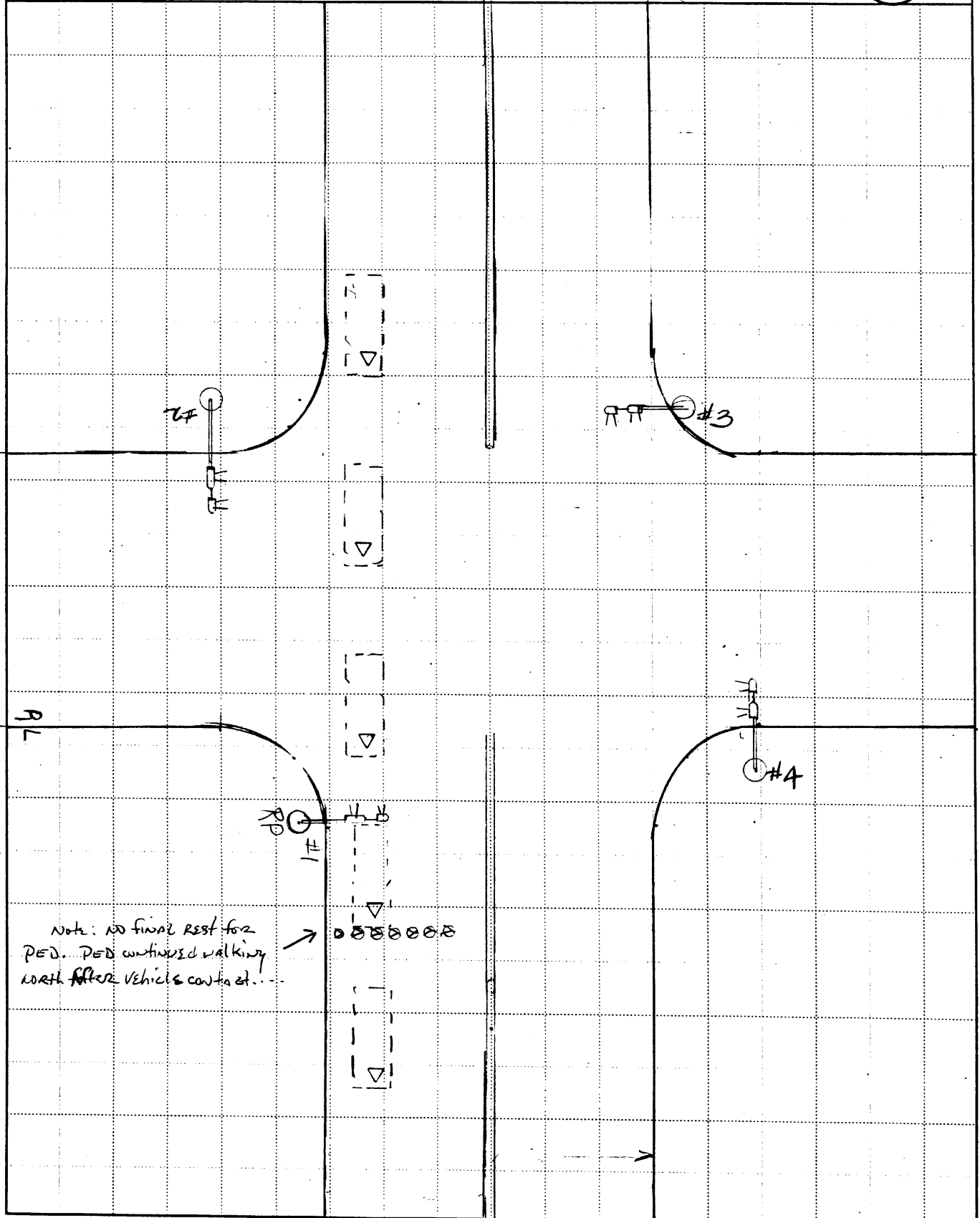
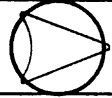
ACCIDENT COLLISION DIAGRAM

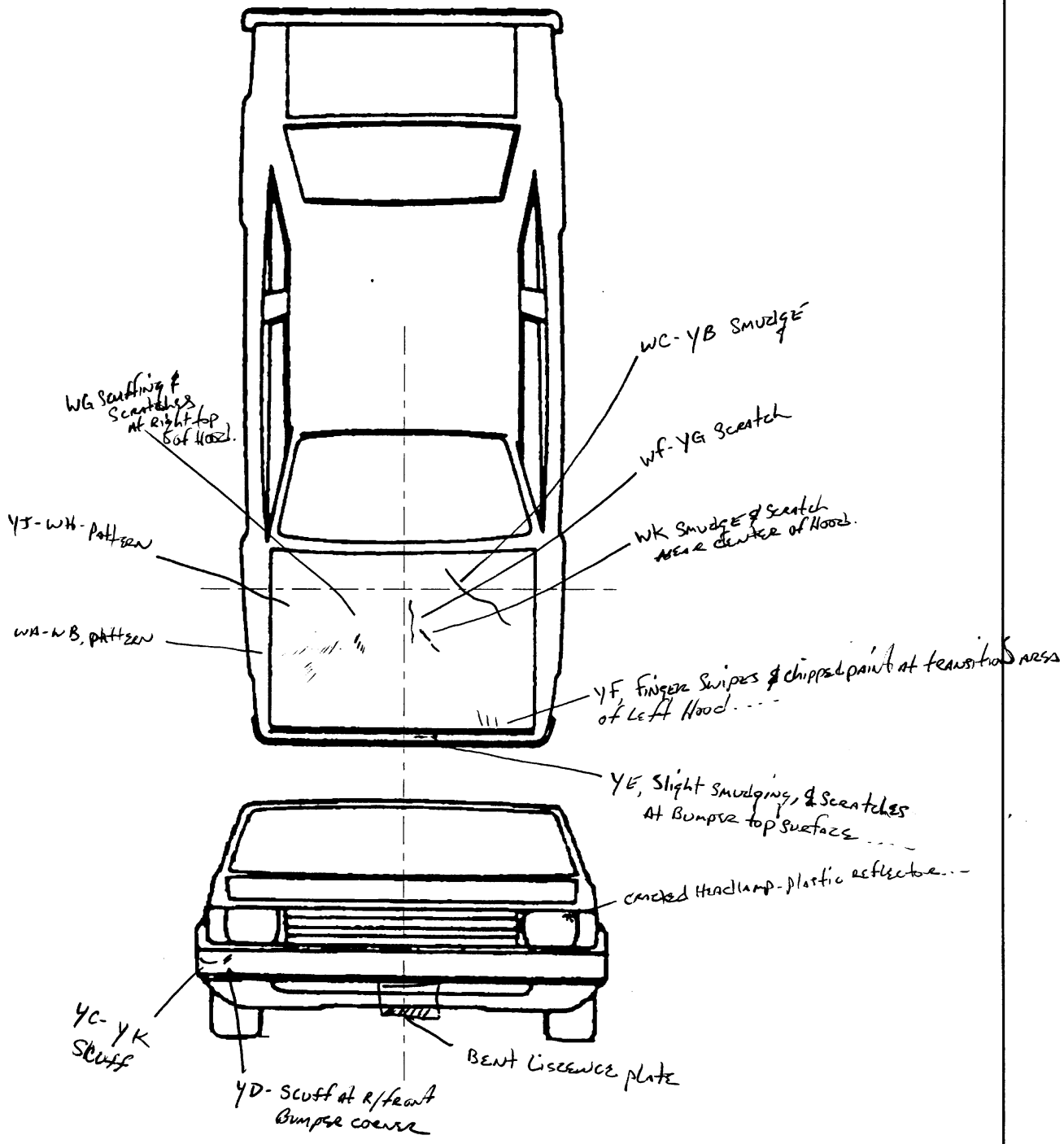

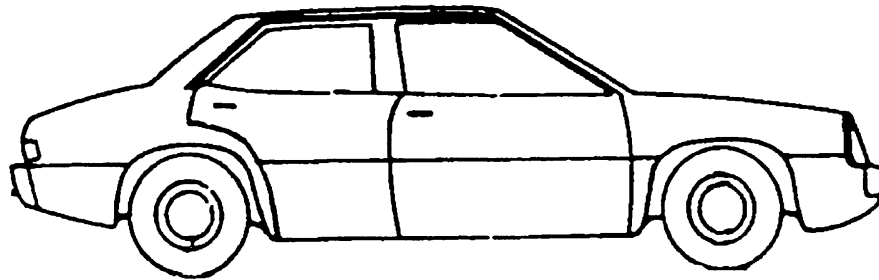
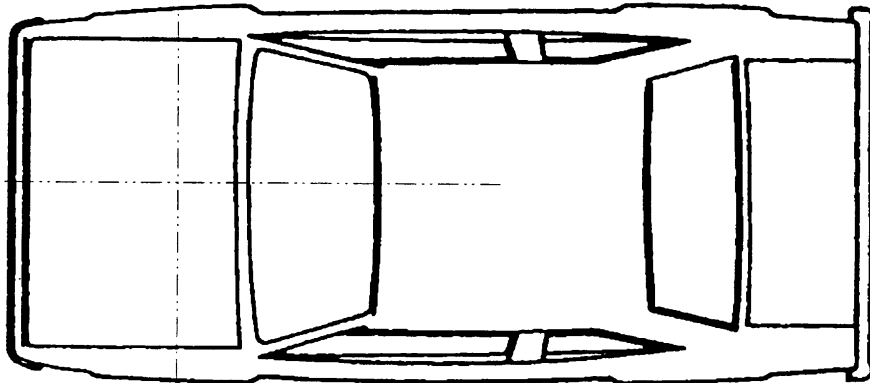
