A. DESCRIPTION OF THE ACCIDENT SEQUENCE AND ACCIDENT PECULIARITIES

(Provide a summary of the accident sequence as well as any particular event of the accident that is noteworthy. Pedestrian injury mechanism and vehicle interaction is the focus, not pedestrian or driver culpability. Do not include any personal identifiers.)

Vehicle 1 was traveling east in the only travel lane available, as there were vehicles parked on either side of the street. Ahead of vehicle 1, some boys were playing football in the street. One of the boys was running in a diagonal (northeast) direction and leaped to catch the thrown football. As the pedestrian was returning to ground, vehicle 1 collided with the right leg of the pedestrian. This collision knocked the pedestrian into the air and forward nearly nine meters. The pedestrian then hobbled to the curb. Vehicle 1 drove forward and parked on the south curb. The pedestrian was transported and released then returned to the hospital a week later for surgical repair to his right leg.

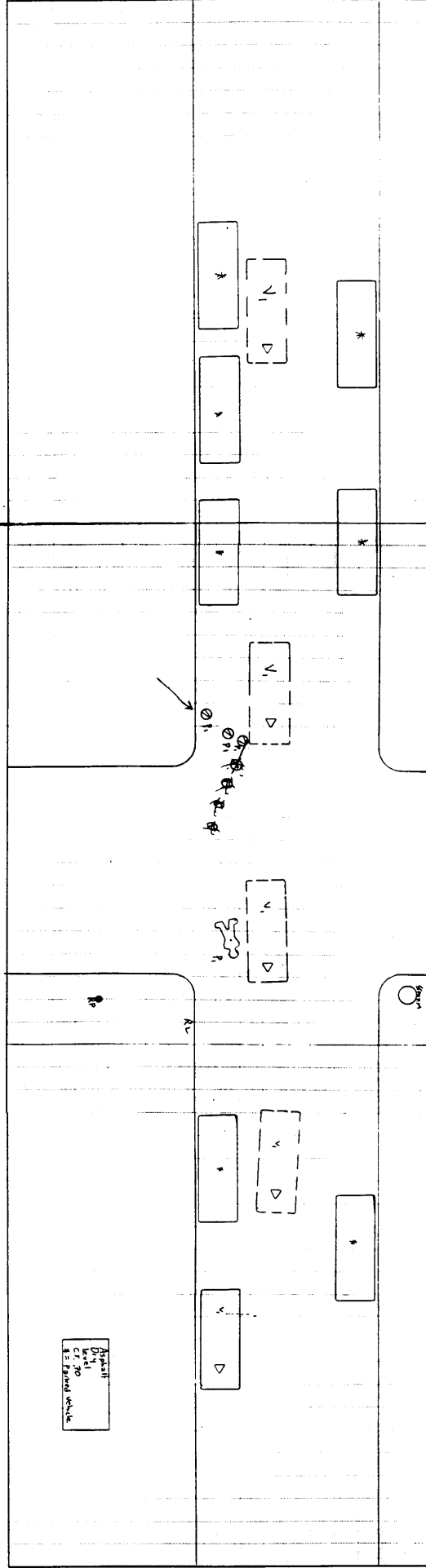

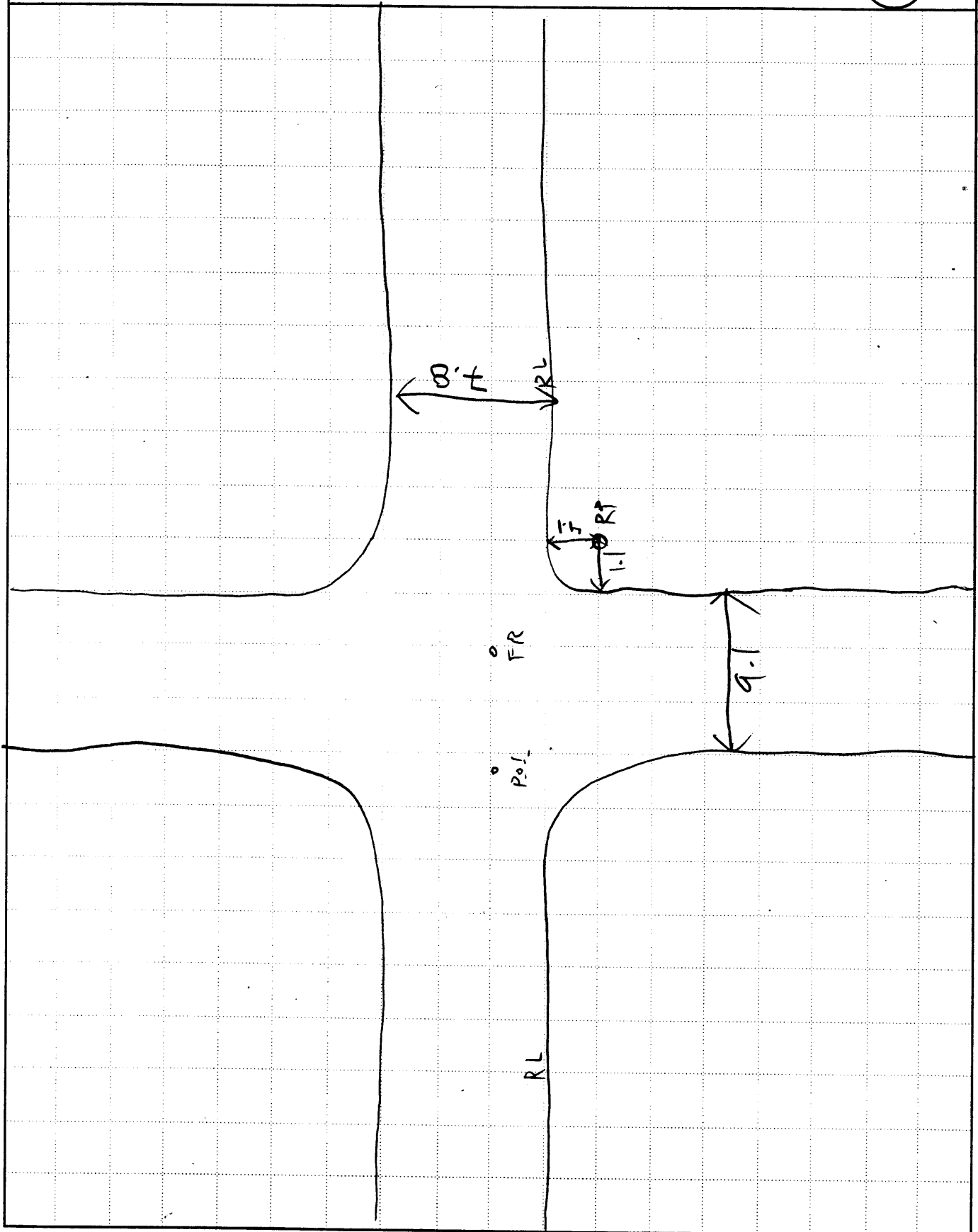
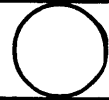


ACCIDENT COLLISION DIAGRAM

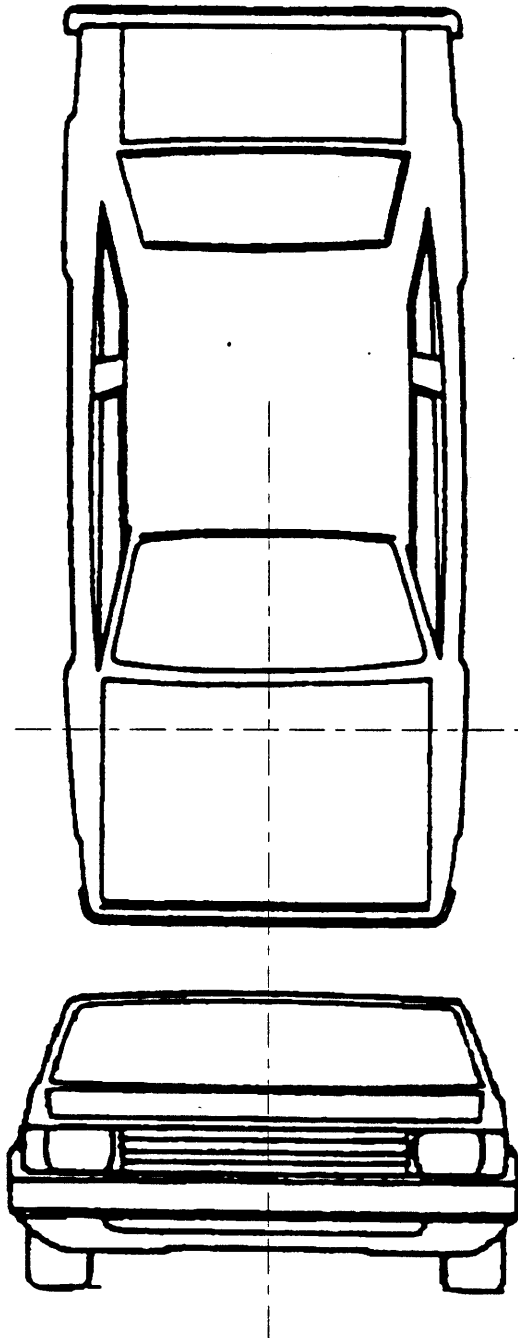

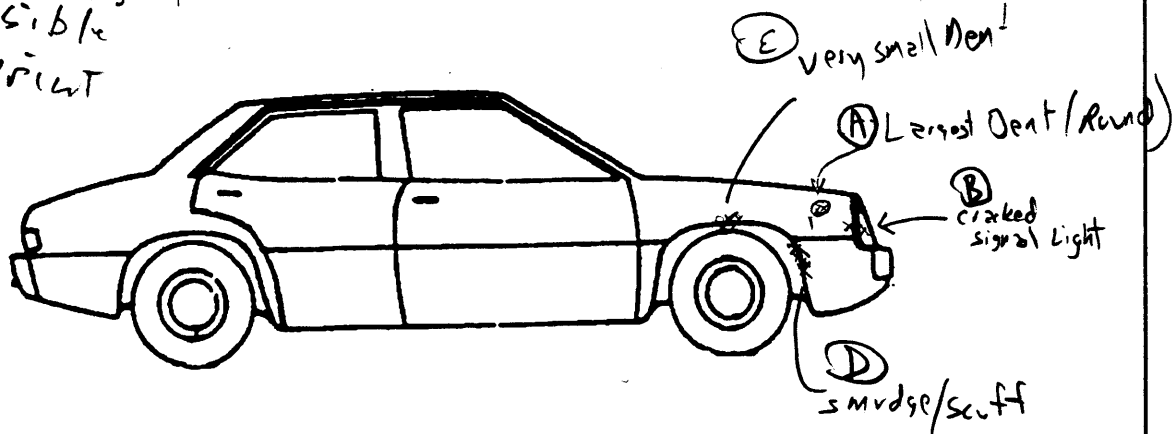
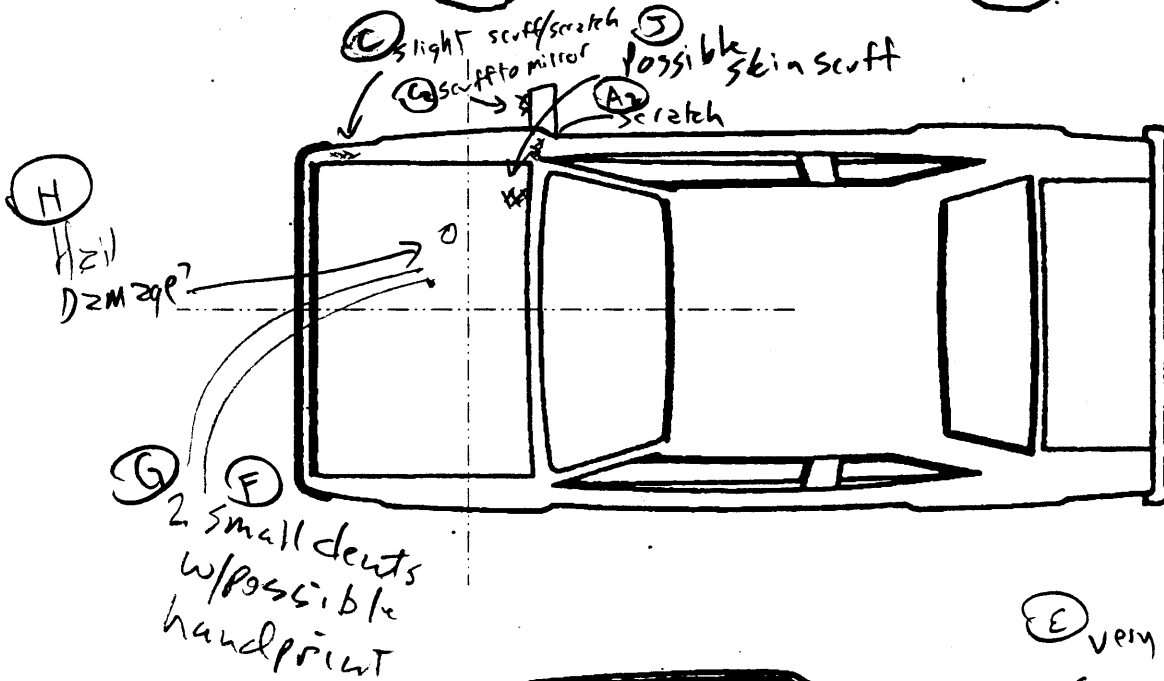
