#### A. DESCRIPTION OF THE ACCIDENT SEQUENCE AND ACCIDENT PECULIARITIES

(Provide a summary of the accident sequence as well as any particular event of the accident that is noteworthy. Pedestrian injury mechanism and vehicle interaction is the focus, not pedestrian or driver culpability. Do not include any personal identifiers.)

Vehicle #1 was stopped at a traffic light facing westbound in the right turn line of a four lane, divided highway. The pedestrian was running northbound in the crosswalk with a straight path of travel. Vehicle #1 started from a stop heading westbound and had his view of the pedestrian obscured by a truck facing westbound in lane two. The pedestrian was contacted on the right side by vehicle #1's driver side view mirror. Vehicle #1 traveled to the middle of the intersection and came to rest in the same lane. The pedestrian continued to northeast corner of the intersection after vehicle #1 had passed.




# ACCIDENT COLLISION DIAGRAM






