Thank you for sending the official letter regarding all weather floor mats.

Here are the answers to the two questions you asked

1. What will be TMS' approach for other vehicle types?
 - Answer: CAD's final approach for other vehicle types will depend upon the outcome of the investigation by CQE and NHTSA. Our current plan for the product is to standardize the caution font , size and location, affix a caution tag to be removed by the customer, install caution notice on floormat cardboard display hanger and assure a caution notice is included in the owners manual. Timing for these enhancements has not been determined.
2. Which department and who in charge of this matter?
 - Answer: The CAD Quality department is responsible for coordinating activities for this matter, William de Manincor and Michael Collinsworth. Changes to the product will be managed by CAD engineering through the ECI process, Jim Wimmer.
