#### 16. Abstract

A 79.3 km/h 70% overlap rear impact test was conducted on the subject 2021 Ford Bronco Sport 5-Door MPV in accordance with the Office of Vehicle Safety Compliance Laboratory Test Procedure No. TP-301R-02 for the determination of FMVSS 301 compliance. The test was conducted at the Applus+ IDIADA KARCO Engineering, LLC. facility in Adelanto, California on July 6, 2021.

The impact velocity was 79.43 km/h and the outside ambient temperature was 36.7° C. There was no Stoddard solvent leakage immediately after the test nor during any portion of the static rollover. The test vehicle appeared to comply with all requirements of FMVSS 301R.

### SECTION 1 SUMMARY OF TEST

#### **SUMMARY**

The purpose of this rear impact test is to measure the performance of the subject vehicle, a 2021 Ford Bronco Sport 5-Door MPV, for FMVSS 301 compliance.

This 79.3 km/h 70% Overlap Rear Impact is sponsored by the National Highway Traffic Safety Administration (NHTSA) under contract number DTNH22-16-D-00029. It was conducted in accordance with the Office of Vehicle Safety Compliance Laboratory Test Procedure TP-301R-02 for FMVSS 301R "Fuel System Integrity – Rear Impact", dated January 2007.

The test was performed at Applus+ IDIADA KARCO Engineering, LLC. on July 6, 2021. Pre- and post- test photographs of the vehicle and ATD's can be found in Appendix A of this report.

Two (2) real-time cameras and three (3) high-speed cameras were used to document the rear impact event.

Two Part 572E 50<sup>th</sup> percentile male anthropomorphic test devices (ATD) were placed in the driver and right front passenger seating positions. Neither of the ATD's were instrumented for this test.

There was no Stoddard solvent leakage after the impact or during any portion of the static rollover. The test vehicle appeared to comply with all requirements of FMVSS 301R-02 "Fuel System Integrity – Rear Impact". FMVSS 301 data is summarized in Data Sheets 4 and 5.

#### STEERING COLUMN ADJUSTMENT

Steering wheel and column adjustments are made so that the steering wheel hub is at the geometric center of the locus it describes when moved through its full range of motion. A digital inclinometer is used to measure a plate which is placed across the rim of the steering wheel for angular measurements. A tape measure is used to measure telescoping steering wheel travel.




FIGURE 2. Post-Test Front View of Test Vehicle




FIGURE 8. Post-Test Left Rear 3/4 View of Test Vehicle




FIGURE 12. Post-Test Right Rear ¾ View of Test Vehicle




FIGURE 21. Pre-Test Underbody View of Fuel Tank




FIGURE 22. Post-Test Underbody View of Fuel Tank




FIGURE 29. Test Vehicle Tire Information Placard
