Dear Ms. Glassmen:

In a recent Engineering Analysis letter (EA02-031) addressed to Mr. J. T. Battenberg III, CEO of Delphi LLC, the Office of Defects Investigation has asked for certain information which, we at Delphi, consider to be confidential. Our request for confidential treatment of these materials follows.

Delphi has enclosed two sets of copies of the materials for which we are requesting confidential treatment as attachments to this letter. Accordingly, we request that the documents stamped "Delphi Confidential" included in this attachment be afforded confidential treatment by the NHTSA. This information is not customarily made public by Delphi and contains trade secrets and commercial information which is privileged or confidential under 5 U.S.C. Section 552 (b) (4), 49 CFR Part 512 and 49 U.S.C. Section 30167(a). A Certificate in support of the request for confidentiality follows this letter.

The Attachments contain Engineering Drawings, Product Requirements, Product Specifications, Test Plans, Test Procedures, FMEA's, PFMEA's, and Quality Control Plans. These materials have commercial value that can only be obtained independently at considerable cost. This information can be used by competitors to identify quality and performance problems or differences, thereby enabling them to improve their own products, without the expenditures associated with the evaluation of products, all at the expense of Delphi Automotive Systems. The Attachments contain commercial information, the disclosure of which would likely result in substantial competitive harm.

Delphi treats the above material as confidential proprietary information available only to authorized Delphi personnel and not otherwise available to the public. These documents are maintained under a record-keeping system which is intended to control dissemination of this material within Delphi, and to assure that it is not disseminated outside the Corporation, except as described in the attached certification made pursuant to 49 CFR Part 512.4(e).

Some of the materials that are submitted herewith were also submitted in conjunction with the GM submission to investigation to EA02-031 and PE02-054; however, to the best of our knowledge, no prior determinations of the confidentiality of the majority of these documents have been made by the NHTSA, other Federal Agencies, or the Federal Courts. Documents such as the ones contained in the attachments, however, have, to the best of our knowledge, normally been granted confidential treatment by the NHTSA in the past. The materials in these attachments are of a type for which a class determination of confidentiality has been made under 49 CFR Part 512, Appendix B.
