Inspection indicated that all parties had completed the inspections of the fire vehicle and the other vehicles removed from the scene, and as we have not been contacted by anyone since that date regarding further inspection of the vehicles, I am writing to advise you that Reliance intends to mitigate its damages in this case by salvaging certain of the damaged vehicles. Reliance will maintain as evidence the vehicle in which the fire started, but intends to sell the remaining damaged vehicles commencing in two weeks.

Accordingly, in the event that you or your principals wish to conduct additional inspection of those vehicles to be salvaged, please contact this office by Friday, March 26, 1999 to make arrangements to conduct such inspections. Any such inspections must be completed on or before Friday, April 2, 1999.

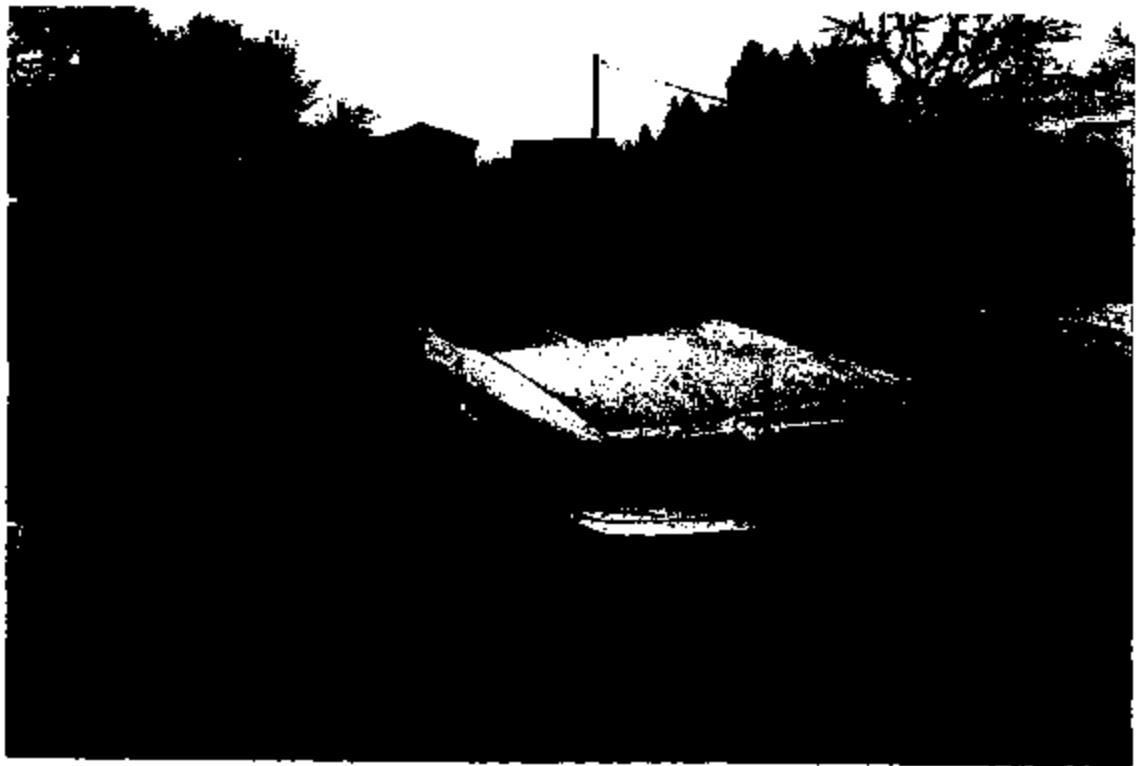
