Dear Ms. Glassman:

Enclosed with this letter are three copies of General Motors' (GM) May 13, 2004 letter to Jeff Quandt, regarding alleged engine fuel rail assembly leaks in 1995 through 1997 Model Year (MY) Oldsmobile Aurora vehicles equipped with 4.0L V8 engines and Cadillec DeVille, Seville, and Eldorado vehicles equipped with 4.6L V8 engines. Two copies include the confidential documents and in the third the confidential information has been removed.


General Motors requests that the documents stamped "GM Confidential" included in electronic Attachment 2 CD GM Confidential; folder labeled "FPE Draft Entry Documents GM Confidential" and file name labeled "IPC RAPIDFAX GM Confidential" be afforded confidential treatment without a time limitation by the NHTSA. This information is not customarily made public by General Motors and contains trade secrets and commercial information which is privileged or confidential under 5 U.S.C. Section 552(b)(4), 49 CFR Part 512 and 49 U.S.C. Section 30167(a).

The documents in the "FPE Draft Entry Documents GM Confidential" reflect GM's application of problem-solving methodologies and contain design information and field performance data having commercial value that can only be obtained independently at considerable cost. This information would give competitors insight into GM's methodologies and disclose confidential information about the design and performance of its products without it having to expend its own resources or to compensate GM for the knowledge it would gain. The disclosure of that commercial, proprietary information would likely result in substantial competitive harm.

Electronic Attachment 2 CD GM Confidential; file name tabeled "IPC RAPIDFAX GM Confidential" reflects GM's application of field problem-solving methodologies and contain field performance data. This information would give competitors insight into GM's methodologies and disclose confidential information about the design and performance of its products without it having to expand its own resources or to compensate GM for the knowledge it would gain. The disclosure of that commercial, proprietary information would likely result in substantial competitive harm.

General Motors treats the above material as confidential proprietary information available only to authorized General Motors and supplier personnel and not otherwise available to the public. The document is maintained under a record-keeping system which is intended to control dissemination of this material within General Motors, and to assure that it is not disseminated outside the Corporation, except as described in the attached certification made pursuant to 49 CFR Part 512.4(e).

To the best of our knowledge, no prior determinations of the confidentiality of these documents have been made by the NHTSA, other Federal Agencies, or the Federal Courts. Documents such as the ones contained in electronic Attachment 2 CD GM Confidential; folder labeled "FPE Draft Entry Documents GM Confidential" and file name labeled "IPC RAPIDFAX GM Confidential",





however, have, to the best of our knowledge, normally been granted confidential treatment by the NHTSA in the past.

The corresponding electronic copies of these documents are being provided on a CD labeled "GM CONFIDENTIAL". If a request for disclosure of any or all of this information is received by the NHTSA, General Motors requests notification of receipt of each such request and, if necessary, an opportunity to further explain the reasons why such material is trade secret and commercial information which should not be disclosed under the applicable statutes and regulations.
