This responds to your letter to the National Highway Traffic Safety Administration (NHTSA) dated January 13, 2004, concerning your model year (MY) 1997 Chevrolet Venture van. Specifically, you alleged that a General Motors Corporation (GM) authorized dealer informed you that your van was not included in a safety recall (NHTSA campaign number 02V-286) and charged you for the replacement of the steering rack and pinion unit and power steering pump in December 2003. You believe that your van should have been included in the recall and the repairs should have been performed without charge to you.

The recall in question addressed steering rack and pinion unit lower pinion bearing failures on certain MY 1996 through 1998 GM vehicles. The recall remedy was to inspect and replace the steering gear pinion bearing. If the inspection indicated that the bearing failure damaged the steering gear, then the steering gear assembly would be replaced. The recall remedy did not address the power steering gear, and there is no recall for power steering pump failure on these vehicles.

After reviewing your letter, we contacted GM. GM informed us that your vehicle was covered by safety recall 02V-286 and that the recall remedy was performed on your vehicle on February 25, 2003. The entire rack and pinion unit was replaced. Mr. Larry Long of my staff discussed this with you by telephone on January 20, 2004, and suggested that you contact the dealer for reimbursement of the charge for replacing the failed rack and pinion unit in your vehicle in December 2003 because GM warrants its replacement parts for 12 months or 12,000 miles, which ever comes first.

We have enclosed a copy of our email correspondence with GM concerning the steering rack and pinion recall remedy on your vehicle.
