Attached is our response to your letter dated January 19, 2005 requesting information on all model year 2001-2003 Volkswagen and Audi vehicles, with curb weight between 2,500 to 3,500 pounds, equipped with both elde-impact/curtain airbags (including the combination thorax/head airbag).

Volkswagen is responding to this request based upon NHTSA's definition of the subject condition. Therefore, we are including reports that contain allegations of "inadvertent" deployment, but also contain clear indication that there has been some type of impact either as described by the reporter, or as evidenced by the presence of crash data stored in the airbag control module and/or physical evidence of impact on the undercarriage, suspension, or wheel and tire. Volkswagen believes that these reports do not represent true "inadvertent" deployment because the deployments (in aggregate) appear to be consistent with design parameters for the impact sustained, but we are including them as such based upon the definition of the subject condition in your inquiry.

For your convenience, each request is restated verbatim and then followed by our response.

Based upon the phone conversation on Friday, February 4 with Mr. Peter Ong of your staff, Volkswagen is providing this response in a timely manner in accordance with the granted extension to March 11, 2005.

Volkswagen's response to this inquiry includes the 2001-2003 Audi TT and certain 2001-2003 Audi A4 and Volkswagen Passat vehicles equipped with both elde-impact/curtain airbags (including the combination thorax/head airbag) that do not exceed a curb weight of 3500 pounds. Volkswagen has previously provided information regarding MY 2001-2003 Jetta, Golf and GTI vehicles in response to PE04-081.

Based on NHTSA's definition of the subject condition, we are including reports that contain allegations of "inadvertent" deployment, but also contain clear indication that there has been some type of impact either as described by the reporter, or as evidenced by the presence of crash data stored in the airbag control module and/or physical evidence of impact on the undercarriage, suspension, or wheel and tire. Volkswagen believes that these reports do not represent true "inadvertent" deployment because the deployments (in aggregate) appear to be consistent with design parameters for the impact sustained, but we are including them as such based upon the definition of subject condition in your inquiry.

- a. In response to this inquiry, Volkswagen has identified and is providing in the attached table consumer complaint counts, none of which are from fleet operators, which relate to, or may relate to, inadvertent deployment (deployment without a physical side impact or crash) of the side-impact/curtain airbage in the subject peer vehicles. Volkswagen has also identified additional cases, as noted in the attached table, which based on the information contained in the report, Volkswagen is unable to determine whether they may or may not relate to the subject condition in the peer vehicles. Volkswagen has also identified an additional case, as noted in the attached table, which based on the information contained in the

report, Volkswagen is unable to determine whether it may or may not relate to the subject condition in the peer vehicles. Volkswagen is also noting in the table those field report counts that are duplicative of vehicles identified in the consumer complaint counts.

- c.
