## BMW Response to NHTSA PE04-081 (Supplemental Information)

## Provide the Information in response to PE04-081 Question 2 separately by model and model year.

The information provided in response to Question 2 by model and model year is contained in Tables 1 and 2 below, specifically, consumer complaints (Question 2(a)) in Table 1, and field reports (Question 2(b)) in Table 2. As indicated in our February 18, 2005 response, there are 21 consumer complaints, 16 field reports, and 2 injury claims that relate, or may relate, to this matter. These totals are also evident when reviewing Tables 1 and 2 below.

In response to Question 2(c) involving injury claims, one claim pertains to the 2002 MINI Cooper, while the other claim pertains to the 2003 MINI Cooper S. As noted in our February 18, 2005 response, we have not been subject to any property demage claims (Question 2(d)), third-party arbitration proceedings (Question 2(e)), or lewsuits (Question 2(f)), involving this matter.
