Dear Mr. Cooper:

This letter is submitted by Mercedes-Benz USA, LLC ("MBUSA") to the National Highway Traffic Safety Administration ("NHTSA" or "Agency") in response to the Office of Defect Investigation's September 30, 2005 request for information relating to the brake light assemblies in certain MY 1998-2001 Mercedes-Benz SLK vehicles.

On October 28, 2005, MBUSA filed a Part 573 Noncompliance report with information on all vehicles equipped with the subject tail light assembly, which includes MY 1998-2004 SLK vehicles. Attached below, following a restatement of the Agency's original request, is the additional information requested by your staff in order to close this investigation.

> State, by model and model year, the number of subject vehicles Mercedes-Benz has manufactured for sale or lease in the United States.

Approximately 69,301 MY 1998-2004 SLK vehicles containing identically designed rear lamp modules were produced for sale or lease in the U.S. The following table identifies the total U.S. production by model year:

MBUSA has received 183 customer complaints and two dealer Field Reports which may relate to the alleged defect. MBUSA has not identified any Crash/Injury Reports, or claims responsive to requests c-d. In response to request e-f, MBUSA is aware of 11 Lemon law arbitrations and lawsuits where the need to repair the brake lamps and sockets was raised as one of the defects related to the case.

MBUSA has received a total of 56,965 warranty claims for right and left side rear lamp assemblies on potentially affected vehicles, although the company has not identified which specific claims relate to the subject condition. The following table identifies total warranty claims by model year:
