The first "Vehicles Assigned" table lists all the cars actually wholesaled to dealers. If the car (VIN) listed does not have a warranty start date, this means it was still in dealer inventory. The State listed is the state of the selling dealer or of the dealer who has the car in inventory. The "Vehicle manufactured" table shows the total number of Cayenne vehicles (all versions) produced by model year. The "Vehicles Not Assigned" are cars not yet to be wholesaled to dealers. Some have warranty start dates that indicates they are in Company Car use.
