In accordance with 49 CFR 512.4, enclosed is Toyota's response to NHTSA's July 24, 2008 letter concerning PE08-041, a defect investigation into Toyota Sienna vehicles.

Toyota claims that the marked portions and identified pages of the attachments provided electronically on the CD-ROM entitled "ATT\_2" herein contain confidential business information. Specifically, within these documents, there is detailed manufacturing process and engineering change information, including quality control improvements and proprietary design changes of the subject components in the subject vehicles. This information is also identified in our internal investigation reports included with the response. Toyota considers all of this information to be proprietary and reflective of the company's significant technological and intellectual investment. Also, it gives insight into the methodology Toyota uses to improve product designs and make decisions on field actions, and would not be available to others without similar efforts and experiences. Toyota requests that this material be treated as confidential permanently.

If this request and supporting affidavit are found to be insufficient to establish Toyota's entitlement to confidential treatment, we ask that, pursuant to 49 CFR 512.19, you afford us the opportunity to supplement this request.
