Complaint Detail Information

On May 8, 2006 will my husband was driving to work the hood on his truck just flew open, the hood was totaled and need to be replaced between buying the hood and haveing it replaced the total was about \$650.00 we just thought it was a freak thing, i called Chrysler to see if there were any recalls for hood latchs and they told me that Dodge Rams 1500 did have a recall for th year 1999, but not 2000 they said they could do nothing for me. My husband was still scared to drive the truck in case it happened again, so just for some extra protection he fastened two bungee cord to the hood.

Well it happened again this time on Sept 5, 2006 the hood flew open even with the new hood and two bungee cords for extra protection, this time not only is the hood total but my wind shield it broking and the dash board crack for the force of the hood flying open.

I called Chrysler and spokw with a women Gina and explain to here the whole situation and advised me to speak with a Mike Brozowsi regarding the issue. Mike advised me to take the truck to the nearst Dodge Dealer and have them give me an estimator damages he said that i would need to pay for the damaged and they will reimburse me.

i called and advised Mike how much the damages were and he said he needed to contact the Dealer (Werener Dodge in Belfc NJ) and he would get back to me. i waited about 1 1/2 weeks and he did not return any of my phone calls so i called the Deale to see if they heared from Mike, John at Werner Dodge advised me that Mike with Chrysler told him they would not be paying any damage, because they found the hood latch not to be faulty.

this was a false statment by both the dealer and Mike wth Chrysler, when i was at the dealer i had to open the hood and remove the bungee cords for them look at the hood.

i need to have this matter taken care of, this truck is a hazard not only to my self but other people on the road. i will not even p my children in this truck.

This is regarding your letter of October 23, 2006.

After reviewing complaint, we must advise you that we are unable to determine any factory responsibility with regard to this incident.

In order for us to become involved in an incident such as this, we would have to find that there was a defect in the vehicle, the defect warranty would have to be in effect, and/or there would need to be a recall. After reviewing our files, we find that the warranty has expired and there are no recalls. Furthermore, when this was investigated previously on more than one occasion, it was determined that there was no problem found with the latches on this truck.

In view of the above, we must concur with the decisions previously rendered as we consider this to be an insurance matter.
