Request for a Confidential Treatment of Information

Dear Sir or Madam:

The NHTSA has opened a Preliminary Evaluation to investigate allegations of clutch pedal assembly mounting bracket failure in model year 2004 through 2006 Mazda RX8 vehicles manufactured by Mazda, and to request certain information (NVS-213dlr/PE09-045). Mazda is requesting portion of our submission be treated as confidential business information.

Mazda is requesting that the design information for the subject vehicle in our submission be treated as confidential business information. The information that we are claiming as confidential has not been shared outside of Mazda, nor disclosed publicly, other than it was sent to your office in our response to the information request for PE09-045 on January 13, 2010. It would result in substantial competitive harm since it relates to design information where the vehicle could not be manufactured without the information. We are requesting that the design information be protected until the termination of the production of the vehicle.

I have enclosed the certification required, two CD-ROMs which contain the document including the confidential information, and a CD-ROM which contains the document with the confidential information removed.
