

Is this warranty extension a recall?

This is not a recall campaign. As this is an extended warranty, there is no corrective action required. Unless you truly believe your vehicle exhibits the above mentioned symptoms you will not need to contact your retailer.

If, within 10 years or 150,000 miles, whichever comes first, your vehicle exhibits the conditions noted above, contact your nearest authorized Volvo retailer to schedule an appointment. Repairs which are a result of a fuel pump failure (smell and/or fuel seepage) will be covered by this extended warranty and performed at no charge at a Volvo authorized retailer.

Have you previously paid for this repair?
