Volkswagen Group of America, Inc., ("VWGoA") is submitting the enclosed documents in response to the above referenced inquiry issued to VWGoA by the Vehicle Integrity Division on August 06, 2010. VWGoA requests that the documents identified below be granted confidential treatment pursuant to 49 C.F.R. Part 512 (2010) and Exemption 4 of the Freedom of Information Act, 5 U.S.C. § 552(b)(4)(2010). The applicable confidentiality standard is set forth at 49 C.F.R. § 512.15(b), which, under the FOIA Exemption 4 case law, applies to information that a submitter is required to provide to a Federal agency. Under this standard, information is exempt from disclosure if its disclosure would cause substantial harm to the competitive position of the submitter (see also National Parks and Conservation Association v. Morton, 574 F.2d 673 (1976).

Release of these documents would reveal internal design and performance criteria that would allow competitors to duplicate this design without incurring the substantial expense associated with the development of their own protocols, thereby allowing the competitor an opportunity to bring competitive products to market sooner and to improve their own development procedures at Volkswagen's expense.
