After our conference call on Monday I mentioned your concern about the difference in the vehicle count between our stated production volumes and the number of vehicles involved in the recall action to our office in Japan. They responded to me that vehicles that had already received the corrective action under TSB C 1099 prior to the initiation of the recall were eliminated from the recall action, since the repair procedure for the TSB is the same as we implemented for the recall action. This is the reason there is a difference between the production numbers and the number of vehicles identified under our recall.

If you need further confirmation, I can ask them to review your summary chart and identify the difference between the production and the recalled vehicles. Please let me know if you require this.
