Scott,

Kia is working on a response to your letter of July 14, 2010 (PE10-023) regarding allegations of fuel expulsion and/or fuel restriction during refueling in the 2003 Kia Sorento (NVS-212lhs/PE10-023). Kia will respond to the categories 1-8, 9 (first part) and 10 on the date requested with all information available at that time.

However, Kia would like to request an extension of time from August 27, 2010 to September 24, 2010 in which to provide its response to the second part of Request No. 9 and Request No. 11.

Previously, Yvonne Dalton of Lee, Hong, Degerman, Kang & Waimey discussed this matter with Lee Strickland on August 10, 2010. At that time, Ms. Dalton noted that Kia would like to request additional time to respond to the second part of Request No. 9 which asks Kia to 1) identify all other Kia vehicles equipped with the identical subject components as the 2003 Kia Sorento and 2) provide separate counts of the numbers of consumer complaints, field reports and warranty claims for those vehicles. The definition of "subject component" includes all fuel-related components.

Kia has determined that many of the fuel system components in the 2003 Kia Sorento were used in other Kia models and model years. Since it is not yet known to Kia which fuel system components might be related to your inquiries, it would be extremely burdensome and time consuming, and not actually helpful, to gather the information for these other models without first knowing which components need to be analyzed. Thus, Kia would like to identify the applicable components as part of its response to Request No. 11 and provide the "other vehicle" information for those components in response to the second part of No. 9.

As to No. 11, Kia has not yet identified any previous evaluations or investigations of difficulties in refueling for the 2003 Sorento and thus has not identified any component or vendor in which to focus the inquiry. Further, Kia will need to understand the various field documents and review the vehicle fuel system design in light of those documents, as well as any design changes, if any, in order to identify the relevant vendors which must be consulted. Finally, it will be necessary to evaluate any component(s) that will be identified in the evaluation and investigation process. Thus, Kia is requesting additional time to perform and complete these steps in the evaluation and investigation process.
