#### JLRNA RESPONSE TO AQ10-001

JLRNA has prepared this response to the Agency's October 14, 2014 letter requesting additional information concerning recalls conducted since January 1, 2000 where it was advised to refrain from driving the subject vehicles until the remedy specified by the recall was completed.

Answers to your specific questions are set forth below. After each numeric designation, JLRNA has set forth verbatim the request for information, followed by its response. Information sources used in preparing this response include the following:

- Records of reports issued pursuant to 49 CFR Part 573, Defect and Noncompliance Responsibility and Reports, made to NHTSA since January 1, 2000.
- Customer letters issued pursuant to 49 CFR Part 577, Defect and Noncompliance Notification
- Jaguar Land Rover's Global Campaign Management Program (GCAMP).

Unless otherwise stated, JLRNA has undertaken to provide its response up to and including October 14, 2014, the date of your enquiry.

Please note: The Jaguar and Land Rover brands have undergone a number of ownership changes since 2000. Recall campaigns issued prior to 2009 were conducted under previous ownership.

# Request 1

Identify, by the recall's NHTSA-assigned identification number, each recall conducted by you since January 1, 2000.

# Request 3

Identify, by the recall's NHTSA-assigned identification number, each recall conducted by you since January 1, 2000 for which the notification required by 49 U.S.C. §§ 30118(b) or 30118(c) contained precautionary advice to refrain from driving the vehicle until the remedy specified by the recall was completed.

## Answer 3

The following recalls contain information directing owners to refrain from driving the vehicle until the recall was completed:

00V036 – Upon receiving a warning lamp the ACE (Active Cornering Enhancement) hydraulic system was leaking, it was advised to stop the vehicle and have it towed to an authorized retailer for service.

00V142 – In the event the serpentine drive belt fails, the ACE (Active Cornering Enhancement) lamp may illuminate and it was advised to stop the vehicle and have it towed to an authorized retailer for service.

00V187 – Should abnormal noise or vibration occur in the brakes, it was advised to stop the vehicle and have it towed to and authorized retailer for service.

00V423 - Upon receiving a warning lamp the ACE (Active Cornering Enhancement) hydraulic system was leaking, it was advised to stop the vehicle and have it towed to an authorized retailer for service. In the even the serpentine drive belt fails, the ACE (Active Cornering Enhancement) lamp may illuminate and it was advised to stop the vehicle and have it towed to an authorized retailer for service.

01V229 – A power interrupt solenoid may malfunction and overheat. It was advised not to drive the vehicle and have it towed to an authorized retailer for service.
