ACTION / SUMMARY INFORMATION

Action: The petition will be evaluated for a grant or deny decision.

Summary:

In a letter dated April 9, 2012, a consumer petitioned the National Highway Traffic Safety Administration (NHTSA) to initiate a defect investigation of alleged stability control failures in model year (MY) 2005 Honda Pilot vehicles. The petitioner alleges that, "in the malfunctioning of these systems, steering failures occur and the brakes apply involuntarily." A copy of the petition will be placed in the public file.

The Office of Defects Investigation has identified a total of 35 reports, including the petitioner's complaint, that appear to be related to inappropriate stability control system activation in the subject vehicles. Inappropriate stability control system activation is generally perceived by the driver as inappropriate autonomous brake application, resulting in unexpected vehicle deceleration, and may also include, as reported in a few of the complaints, allegations of steering pull and/or lane departure. The first incident was reported to ODI in 2006. Ten of the incidents have been reported in the last 12 months.

The petition will be evaluated for a grant or deny decision.
