Dear Ms. Timian:

I am writing on behalf of my client, Stabilus, Inc. (“Stabilus”), with respect to the above-captioned matter. Stabilus is in receipt of your letter dated October 1, 2012, which was received electronically on that date and by certified mail on October 5, 2012. The Office of Defects Investigation (“ODI”) has requested that Stabilus provide a written response to the letter within 10 days of receiving the letter, which, using the date Stabilus received the letter electronically, would be October 11, 2011. Although we have been working diligently on a response to the requests for information, we will require some additional time beyond the 10 day deadline to complete everything. Therefore, we would respectfully request a short extension until Friday, October 19, 2012 to submit the response to your office. I contacted Mr. Ansley about this request and he advised me to send the request in writing to you on my firm’s letter.

If you could advise me at your earliest convenience whether ODI will consent to this request for a short extension, I would appreciate it. Thank you for your consideration of this request.
