## **ACTION / SUMMARY INFORMATION**

Action: A Preliminary Evaluation has been opened.

#### **Summary:**

The Office of Defects Investigation has received 54 complaints alleging incidents of engine stall while driving in model year (MY) 2006 Chrysler 300C, Dodge Charger and Magnum vehicles. All complaints with reported Vehicle Identification Numbers (VIN) include vehicles equipped with 5.7L or 6.1L 8-cylinder HEMI engines. Forty eight (48) complaints alleged multiple stall incidents and all fifty-four (54) complaints reported that the vehicle stalled while driving after refueling at a gas station. Seven (7) complaints reported that either the vehicle could not be immediately restarted or difficult to restart. The complaints show an apparent increasing trend, with over 50 percent received within the past eight months.

A Preliminary Evaluation has been opened to assess the scope, frequency and potential safety consequences associated with the alleged defect.
