On behalf of Kia Motors Corporation and Kia Motors America, Inc. ("Kia"), Kia Motors America, Inc. ("KMA"), hereby requests that certain documents being provided in Kia's response to the General Order to Motor Vehicle Manufacturers in In re Kia Sorento Sunroofs (EA14-002) dated June 16, 2016 be treated as confidential. Two (2) confidential copies are being submitted as Kia is seeking confidential treatment of the documents in their entirety. In accordance with 49 C.F.R. 512.3(c), confidential business information includes trade secrets or commercial or financial information that is privileged or confidential as described in the Freedom of Information Act. See 5 U.S.C. 522(b)(4). Commercial information is considered confidential if it has not been publicly disclosed and if its release is likely to cause substantial harm to Kia's competitive position. 49 C.F.R. 512.3.

In its Response, Kia provided certain testing data conducted by it or on its behalf as well as engineering changes that it claims is confidential business information. Specifically, Kia submitted the following:
