GENERAL MOTORS LLC'S RESPONSE TO THE GENERAL ORDER DIRECTED TO MANUFACTURERS

General Motors LLC ("GM") submits the following report in response to the National Highway Traffic Safety Administration's ("NHTSA") General Order Directed to Motor Vehicle Manufacturers dated April 14, 2016 (the "General Order").

Preliminary Statement

Unless otherwise noted, GM's responses rely on the definitions provided on page 3 of the General Order, as clarified by Elizabeth Mykytiuk of the NHTSA Office of Chief Counsel in an email dated April 21, 2016. GM's responses relate to 2006 through 2016 model year vehicles manufactured by GM, and are based upon: (i) a reasonable search for and review of relevant GM business records; and (ii) interviews with selected GM personnel familiar with the development, manufacture, and/or performance of panoramic sunroofs in relevant GM vehicles. GM's responses are based on the information it has reviewed to date and reflect its current information and belief.

GM's Responses

A. Request 1

Request

Describe the history of panoramic sunroofs in the vehicles you manufacture. Your response should include, but not be limited to, the reason(s) you decided to add panoramic sunroofs as an option, the model(s) and model year for which you first offered this option, and the timeline of the development and decision-making that led to the introduction of panoramic sunroofs.

GM's Response

In the late 1990s, GM began the development and decision-making process that led to the introduction of a panoramic sunroof on the 2004 model year Cadillac SRX. Panoramic sunroofs were shown on competitive vehicle offerings by our supply base, and GM became interested in offering a larger open roof view to our customers. This larger view was seen as a means to generate customer enthusiasm and help to drive sales, profitability, and market share. GM has increased its usage of panoramic sunroofs since the introduction of the 2004 MY Cadillac SRX.

B. Request 2

Request

Identify and enumerate the total population of vehicles you manufactured that contain a panoramic sunroof as original equipment. Your response should be broken down by make, model, and model year.

GM's Response

Table 1 below contains the number of vehicles that GM has manufactured for sale or lease in the United States with a panoramic sunroof as original equipment.

C. Request 3

Request

For each panoramic sunroof identified in your Response to Request No. 2, provide the following information: (i) the name and contact information for the sunroof manufacturer; (ii) the number of glass panels; (iii) the size of the glass panel(s) (length X width in centimeters); (iv) the thickness of the glass panel(s) (millimeters); and (v) the standard to which the sunroof was

manufactured. Your response should include an explanation of any changes made between models and model years.

GM's Response

GM's response to Request 3 is attached as **Exhibit A**. All vehicles listed in response to Request 2 used the same panoramic sunroof in every model year of that vehicle.

D. Request 4

Request

Identify, by make, model, and model year, the number of incidents involving an allegation that a panoramic sunroof has spontaneously shattered, and state the number of injuries or fatalities associated with such incidents.

GM's Response

GM's response to Request 4 is attached as **Exhibit B**.

E. Request 5

Request

File a report of every incident involving an allegation that a panoramic sunroof has shattered spontaneously in a vehicle manufactured by you, of which you are aware by any means (including but not limited to consumer complaints, lawsuits, and media reports). The report shall include the following information: (i) the date on which you were first notified or learned of the incident; (ii) the name of the individual involved in the incident; (iii) the contact information for counsel representing that individual (if applicable); (iv) the make, model, and model year of the vehicle; (V) the vehicle identification number (VIN); (vi) the date, location, and description of the incident (including whether the vehicle was stationary or in motion when the incident occurred); (vii) the number and description of any injuries or fatalities; (viii) a summary of your current understanding as to the nature of the incident and/or the cause of the breakage (including whether a rock or other item of road debris was found); and (ix) a summary of any other information relevant to your investigation of the incident. Your report should be in the format attached as Exhibit A.

GM's Response

GM response to Request 5 is attached as Exhibit C. The data in Exhibit C was obtained from a reasonable search of Customer and Relationship Services (CARS) (formerly Customer Assistance Center or "CAC") database, Technical Assistance Center ("TAC") database and Team Connect Data Warehouse (Team Connect). It contains customer allegations, dealer observations, and other third-party allegations that GM copied verbatim from these sources and that GM has not independently verified. GM has not investigated these claims and therefore has not made a determination regarding the nature of the underlying incident and the root cause of any alleged sunroof failure.
