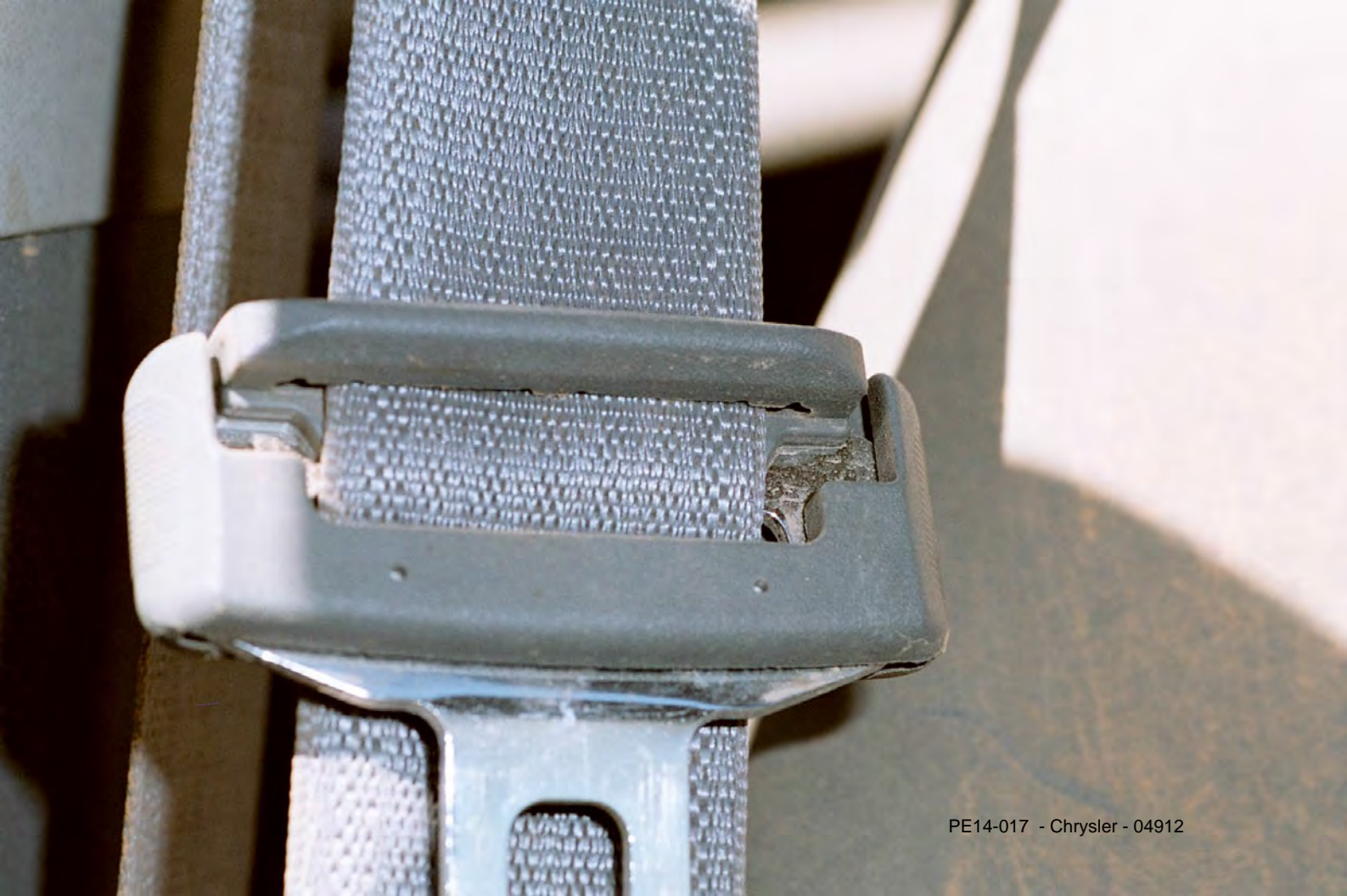

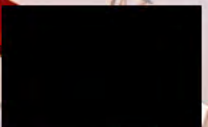

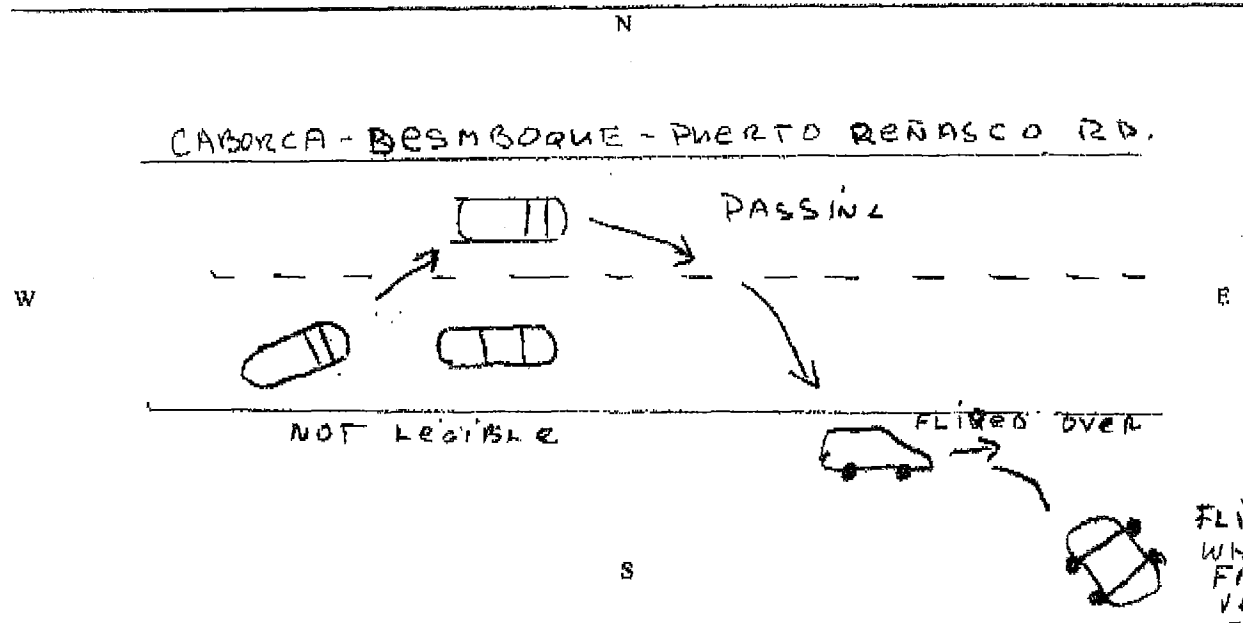

REGARDING: Information About Traffic Accident

With all due respect and in the most attentive manner, we permit ourselves to inform you that at about 16:30 hours, we were informed by our Caborca office of an accident that occurred at Kilometer 35 on the highway between Caborca - Desemboque, one that was classified as leaving the blacktop and rollover of vehicle with minor injuries to a person. This is the only vehicle involved in the accident which is described, as follows:

Make: Jeep; Model: Cherokee; Year: 2005, Color: Green; with License Plate No. [REDACTED] owned by the Driver whose name is [REDACTED] 21 years of age, home address of [REDACTED] Douglas, Arizona, U.S.A., who presented Driver's License No. [REDACTED]

FACTS AND CAUSES: Through investigation conducted by the undersigned, together with the Driver's version, the following was obtained:

Being the only vehicle on the Caborca - Desemboque roadway, driving eastbound at a moderate speed, arriving at Kilometer 35, as she tried to pass a vehicle, but due to the lack of precaution and the loose gravel on the road, after passing, the Driver lost control of the steering as she passed the vehicle, towards the right side, left the blacktop road causing the rollover towards the left, coming to rest at 20 meters from the blacktop road, with its wheels in the air, and the front of the vehicle facing south, said accident having occurred as mentioned above.

SKIDS: Ten meters before the rollover, and on the blacktop.

INJURIES: [REDACTED] 15 years of age, who received scratches which will take about 15 days to heal, according to the Medical Health Center Doctor on call.

DAMAGES: With respect to the vehicle, the damages are unestimatable because the entire body of the car was damaged (totalled).

ADDITIONAL INFORMATION: The vehicle was towed by Estrada Towing to the municipal yard, properly inventoried and secured. Red Cross transported the injured person to the Town Medical Health Center. Inventory was taken again, Towing forms and Citation were issued.

This is to inform you of the above matter for any legal matters that may arise.

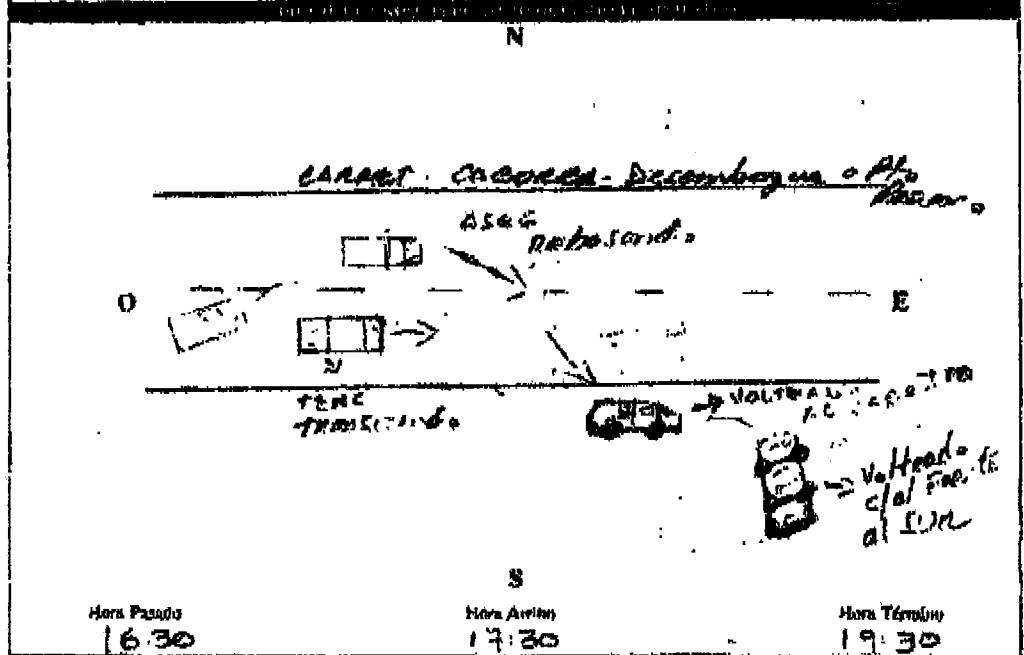
