Request 8

Describe all assessments, analyses, tests, test results, studies, surveys, simulations, investigations, inquiries and/or evaluations (collectively, "actions") that relate to, or may relate to, the alleged defect in the subject vehicles that have been conducted, are being conducted, are planned, or are being planned by, or for, VW. - d. Brief summary of the subject and objective of the action;
- e. Engineering group(s)/supplier(s) responsible for designing and for conducting the action; and
- f. A brief summary of the findings and/or conclusions resulting from the action.

For each action identified, provide copies of all documents related to the action, regardless of whether the documents are in interim, draft, or final form. Organize the documents chronologically by action.

Response 8

In response to this inquiry, Volkswagen is providing a table outlining each item in subparagraphs a) through f) in a file, entitled REQUEST NUMBER EIGHT DATA in the folder attached hereto as Exhibit to Request 8.

In the 5th partial response, Volkswagen provides 236 non-confidential and 22 confidential documents (inclusive of 10 documents which contain information in the German language and have been translated to English). The documents are listed by category and provided in chronological order. Confidential documents have been submitted under separate cover to NHTSA's Office of General Counsel under Part 512.

Where documents provided contain information in either German or Spanish language, Volkswagen provides an English language translation copy.

Additionally, Volkswagen provides an index in the Exhibit to Request 8 folder for the responsive documents.

Volkswagen notes that under European privacy laws personal identifying information has been redacted where required. Additionally, redactions were made for the following reasons:

- content is not responsive to the inquiry;
- content is not relevant to or regarding the U.S. market;
- content is related to complaints other than the alleged defect;
- content is deemed confidential and has been submitted to NHTSA's Office of General Counsel, under 49 CFR Part 512
