- Only the driver will be able to pick up the rental car at the counter and must present a valid driver's license. An additional driver may be added at the counter for a fee payable directly to the rental car company.
- An additional licensed driver meeting minimum age requirements can be authorized at the counter if the additional driver is a spouse, employer, colleague or listed on the renter's contract as authorized.
- Budget Rent a Car will charge the driver at the rental counter for optional items you add to your reservation, including any child seats or special requests.
- You have indicated that the driver will provide a credit card in his/her name for the refundable security deposit required at the rental counter. As a reminder, bank debit cards cannot be used as credit for car rentals and are subject to certain restrictions. The security deposit will be released back onto your card once the vehicle is returned.
- The amount needed for the refundable security deposit required at the rental counter varies due to car type, rental period, and optional items, not including the cost of any additional items added at the counter. The rental partner can verify the exact amount.
- Some states collect fees, or tolls, for access to certain roadways. Some tolls may be cashless and fees are paid via an electronic toll collection program. Budget Rent a Car may have a specific policy regarding cashless tolls, or offer the option to participate in their electronic toll collection program. 
- * I have a currently valid drivers license, not suspended, revoked, expired, cancelled, surrendered or improperly altered.


