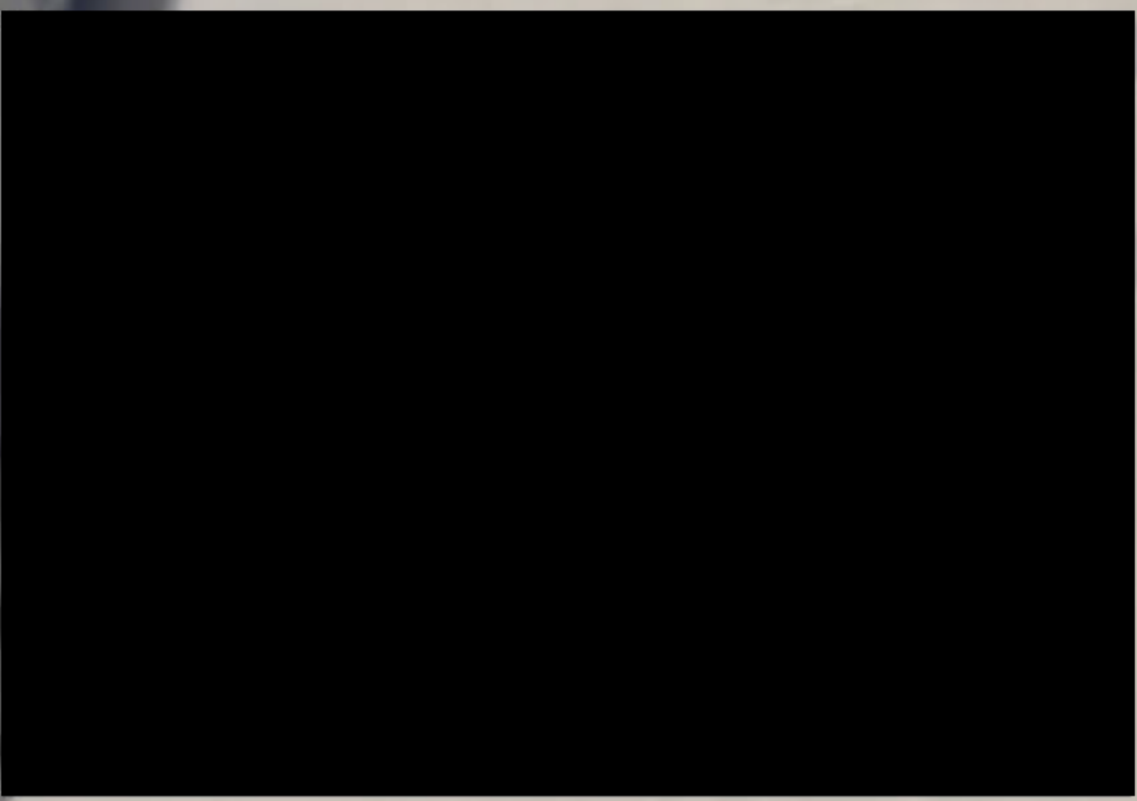

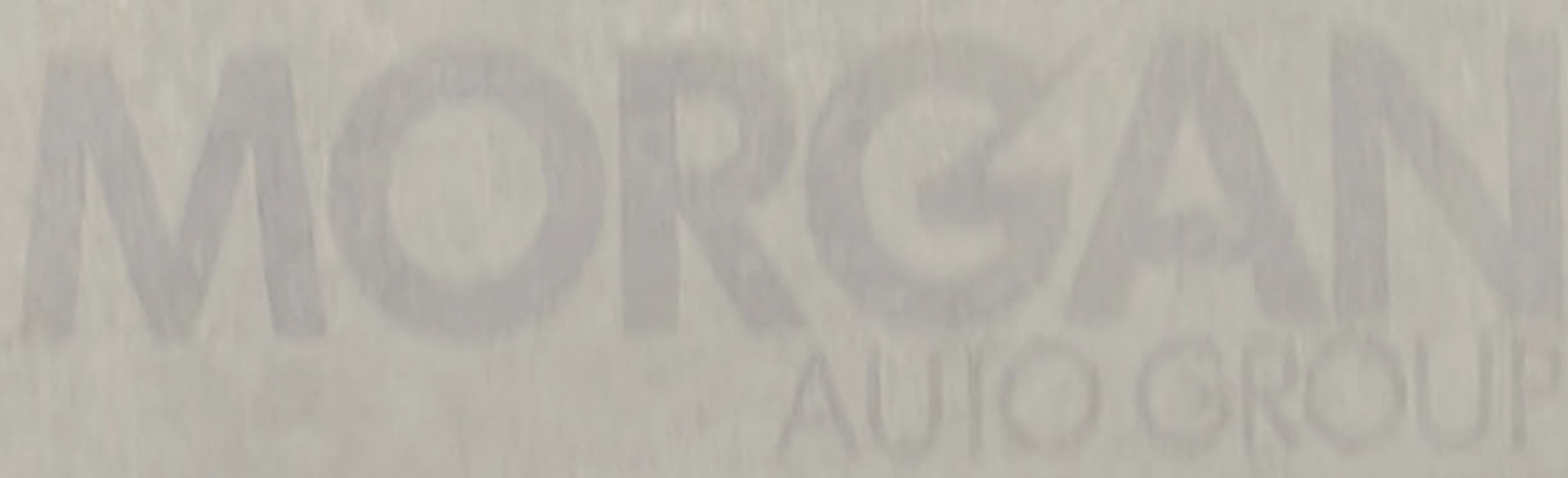
**Miscellaneous Shop Supplies and Hazardous Waste Disposal Charges**
